The Arizona Center for Disability Law (ACDL) and its partners are excited to announce the 12<sup>th</sup> Annual African American Conference on Disabilities (AACD) will return in-person for 2023. It is the premiere comprehensive disability conference in the United States that addresses the intersection between race and disability. The conference examines avenues for self-advocacy to ensure the effective provision of services, resources, and enforcement of civil rights in the African American and disability communities.

As a precursor to in-person conference, an intimate virtual seminar will be held during the month of February in honor of Black History Month. Dates and times will be announced in the coming weeks.

African Americans with disabilities face challenges of race and disability discrimination that the broader community overlooks and views with indifference. The goals of the conference are to eliminate barriers for persons with disabilities, and to provide the African American community, organizations and individuals who service the community, with cultural and linguistic competent information and resources. Participants will attend three general sessions and have an opportunity to select from twenty (20) disability-related workshops.
